#### 11 Car Accidents Here In October

Eleven automobile accidents were investigated by San Benito police in October, none of which involved deaths, according to the monthly accident report issued by Police Chief William Gilbert.

Three persons were injured in wrecks last month. Vehicle damage totaled \$2,705, an average of \$246 per accident, and other damage \$372.

In October, 1958, there were no fatalities and seven inuuries in 14 accidents. Vehicle damage was high — \$9,960 for an average of \$711.50 an accident. Other property damage totaled only \$15.

Mrs. Vera Fitzgerald was the plaintiff and officials of Resaca-Village were defendents. A move to call another incorporation election is awaiting the judgement on the original incorporation.
