

Ordinance Annexing Territory that is Inhabited  
By Less Than Three Voters or Is Unoccupied

ORDINANCE NO. 2006-005-018

AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE TOWN OF BAYVIEW, CAMERON COUNTY, TEXAS AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY LIMITS SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY AND GRANTING TO ALL THE INHABITANTS OF SAID PROPERTY ALL THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID INHABITANTS BY ALL OF THE ACTS, ORDINANCES, RESOLUTIONS, AND REGULATION OF THE SAID CITY.

WHEREAS, the articles of incorporation of the Town of Bayview, Texas, an incorporated city, authorizes the unilateral annexation of this territory, subject to the laws of this state.

WHEREAS, the procedures prescribed by the articles of incorporation of the Town of Bayview, Texas, and the laws of this state have been duly followed with respect to the following described territory, to wit:

10.21 acres - Abstract 2 Bayview citrus Groves Unit 3, Section 2, Block 51

10.35 acres - Abstract 2 Bayview citrus Groves Unit 3, Section 3, Block 2

5 acres - Abstract 2 Bayview citrus Groves Unit 3, Section 3, Block 3N, 5W

13.69 acres – Extension of Bayview Citrus Groves Unit 2, Block 25


10.73 acres – Bayview Citrus Groves Unit 2, Block 26

NOW, THEREFORE, be it ordained by the Board of Alderpersons of the Town of Bayview, Texas:

That the heretofore described property, is hereby annexed to the Town of Bayview, Texas, Cameron County, Texas, and that the boundary limits of the Town of Bayview, Texas, are hereby extended to include the above described territory within the city limits of the Town of Bayview, Texas, and that the same shall hereafter be included within the territorial limits of said city, and said land and the inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the Town of Bayview, Texas, and they shall be bound by the acts, ordinances, resolution and regulations of said Town of Bayview, Texas.

Severability: If any provision of this ordinance or application thereof to any person or circumstance, shall be held invalid, such invalidity shall not affect the other provisions, or application thereof, of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are hereby declared to be severable.

PASSED: by an affirmative vote of the Board of Alderpersons of the Town of Bayview, Texas, this 18<sup>th</sup> day of May, 2006.
